During the conversion process multiple first and middle names may have been eliminated or modified. If you wish to change the way your name is recorded on the VRIS, you may do so, providing it meets State VRIS requirement that it contains no spaces or other special characters, except for a hyphen.

**Mail TO** A 'Y' in this column designates head of household. If you wish to change this, place a 'Y' next to the name of the selected individual.

**DATE OF BIRTH** If your date of birth is incorrect please make appropriate changes.

**OCCUPATION** Enter your current occupation..

**MOVED/DECEASED** If your If this individual has moved or is deceased please indicate with an 'M' or 'D'.

**NATIONALITY** If you are not a U.S. Citizen your nationality should be indicated.

**POLITICAL PARTY** 'D' for DEMOCRAT, 'R' for REPUBLICAN, 'U' for UNENROLLED  
(An unenrolled voter is one who is registered to vote but has NOT selected a party affiliation.)

**PUBLIC SAFETY** Check this box if you are a member of a public safety agency and work and live in this community.

**U.S. VETERAN** If you are a veteran of the U.S. Armed Forces, indicate with a 'Y'.

**DOG** Indicate the number of dogs in household.

**VOTER CHANGES** If a voter changes their name, address or party, he/she must sign their name on the line provided.
