Automatic Meter Reader device for water meter, includes installation: \$132.56
- Test meter for accuracy, 5/8", 3/4", 1", 1-1/2", 2": If meter is correct owner pays \$100, If larger than 2": test not done by FRWD. Owner arranges and pays.
- Bulk water, per truck load:.....\$72.00/6,000 gal truck
(rate basis: \$0.012/gallon for first 500,000 gal. per calendar year; thereafter 501,000 to 1,000,000 gallons: \$0.010 per gallon. Over 1,000,000 gallons: \$0.008 per gallon.)
- Loan of backflow preventer for hydrant use: \$1,500 security deposit, + \$200/mo. for presumed water use (may also be billed by metered amount).
- Wood-cutting permit: \$35/permit.
